<b>CLASS 2</b>	Any <b>NEW</b> motor vehicle not in Class 1, any <b>USED</b> motor vehicle manufactured not more than two (2) years prior to the year in which the sale is made, and any <b>NEW</b> commercial vehicle or <b>USED</b> commercial vehicle manufactured not more than one (1) year prior to the year in which the same is made - 21% per annum on the unpaid balance.  As of <b>January 1, 2015</b> , this will apply to any <b>USED 2015, 2014, and 2013</b> motor vehicle and any <b>NEW 2015</b> commercial vehicle or <b>USED 2014, 2013, or 2012</b> commercial vehicle, also any <b>NEW</b> motor vehicle not in Class 1.	12 months	\$11.74
